Notes for Joseph Layton Mauzé Jr.:

J. Layton Mauze, Jr. served as Pastor of the Central Presbyterian Church of St. Louis County, Missouri from 1949 till 1969. It is notable that his father also was Pastor of that church from 1902 till 1917.

My brother-in-law, the Rev. Dr. Andrew Albert Jumper, who married my sister, Elizabeth Anne Sharpe, was Pastor of Central Church following Dr. Mauze in 1970.

He married Abby Rockefeller (daughter of John Davison Rockefeller Jr. and Abigail Greene Aldrich) on 23 Apr 1953 in Home of Abby's brother, Laurance Rockefeller in New York. She was born on 09 Nov 1903. She died on 27 May 1976 in New York City, New York.

Notes for Jean Mauzé:

Jean Mauzé (January 15, 1903 – January 1974) was a Manhattan banker, senior vice president of [United States Trust Company](#) and married [Abby Rockefeller](#) on April 23, 1953. After his wife created the Greenacre Foundation in 1968, he donated Greenacre Park to [City of New York](#) in 1971.

He was the son of the Rev. Dr. J. Layton Mauzé. Dr. Mauzé was pastor at the Central Presbyterian Church of St. Louis County, Missouri for a couple of decades up till 1969. In 1970, my brother-in-law, the Rev. Dr. Andrew Albert Jumper, became pastor of that church, coming from the First Presbyterian Church of Lubbock, Texas. Dr. Jumper had married my sister, Elizabeth Anne Sharpe Jumper.

Jean's father had a brother, the Rev. Dr. George Mauzé. Mauze graduated from [Davidson College](#) in 1923. He was later awarded an honorary [Doctor of Laws](#) degree in 1972.

During [World War II](#), Jean served in Navy in the Pacific and was a commander in the Reserve. In 1941, he joined the [United States Trust Company](#) in New York and by 1961, was Senior Vice President. Although he retired from U.S. Trust in 1968, he continued to serve the bank as a consultant.

Mauzé was a member of the investment advisory group of [Commercial Union Insurance Company of New York](#), a director of the [Freeport Minerals Company](#), the [Brooklyn Savings Bank](#), One William Street Fund, Inc., and a member of the finance committee of the [Rockefeller Brothers Fund](#). He also served as a governor, financial vice president and chairman of the finance committee of [New York Hospital](#).

On April 23, 1953, he married [Abby Rockefeller](#) (1903–1976), the eldest child and only daughter of [John D. Rockefeller, Jr.](#) and [Abby Aldrich](#). The ceremony took place at the home of Abby's brother, [Laurance Rockefeller](#) in New York, with Jean's brother, Rev. Dr. George Mauzé, a Presbyterian minister, officiating. Abby had been widowed in 1949, after the death of her second husband, Dr. Irving Hotchkiss Pardee.^[1]

He was a member of the [University Club](#) of New York and the [Piping Rock Club](#) in [Locust Valley, NY](#).^[2]

He was born in Huntington, West Virginia in 1936 to the late Sue Dunn and Dr. J. Layton Mauzé, Jr. Dr. Mauzé attended McCallie Military Academy in Chattanooga, TN, achieved his B.A. from Westminster College in Fulton, MO in 1959, his B.D. from Union Theological Seminary in Richmond, VA in 1962, and his Doctor of Divinity from Westminster College in 1977. He was ordained on July 22, 1962 by the Presbytery of Winchester, Synod of Virginia.

A member of First Presbyterian Church in Statesville, Dr. Mauzé served as Senior Pastor for the church from 1971-82. Even in retirement, Dr. Mauzé continued his ministerial work, serving as the interim pastor for First Presbyterian Church in Asheville, NC, Second Presbyterian Church in Charleston, SC, First Presbyterian Church in Raleigh, NC, and First Presbyterian Church in Gastonia, NC.

Dr. Mauzé was very active in the communities where he served as Pastor. He was on the Board of Directors for Leadership Fort Smith and Arkansas Valley Habitat for Humanity. He acted as President on the Hospice House Board in Fort Smith, AR, Trustee for Sparks Regional Medical Center and Chair of the Pastoral Care Committee for Sparks Regional Medical Center in Fort Smith, AR.

Highly regarded as a supporter of quality Christian education, Dr. Mauzé was selected to serve as a trustee for Austin College in Sherman, TX, Lyon College in Batesville, AR and Presbyterian School of Christian Education. He was Chair of the Coordinating Council, Presbytery of Arkansas and a member of the Committee on Ministry, Presbytery of Arkansas and Arkansas Presbyterian Foundation.
